OVERALL GOAL

Consolidate stability in Northern Uganda, reduce poverty and under-nutrition and strengthen the foundations for sustainable and inclusive socio-economic development

The general objective of this project is aligned with the overall objective of the Development Initiative for Northern Uganda (DINU), hence the United Nations Capital Development Fund (UNCDF) is implementing activities across the three specific objectives of the DINU programme, namely: Food Security, Nutrition and Livelihoods, Transport Infrastructures, and Good Governance.

Specifically, UNCDF:

- Runs a funding facility for agribusiness SMEs involved in value addition to improve access to finance for agro processors through development grants, loans and guarantees.
- Supports rehabilitation of district and community access roads in target districts to connect local and regional markets and improve the access of local communities to jobs and social services.
- Manages a funding facility for target local governments to help them invest in local infrastructure for climate change adaptation and economic empowerment of women and young people.
- Strengthens the capacities of local governments to fulfil their core mandates

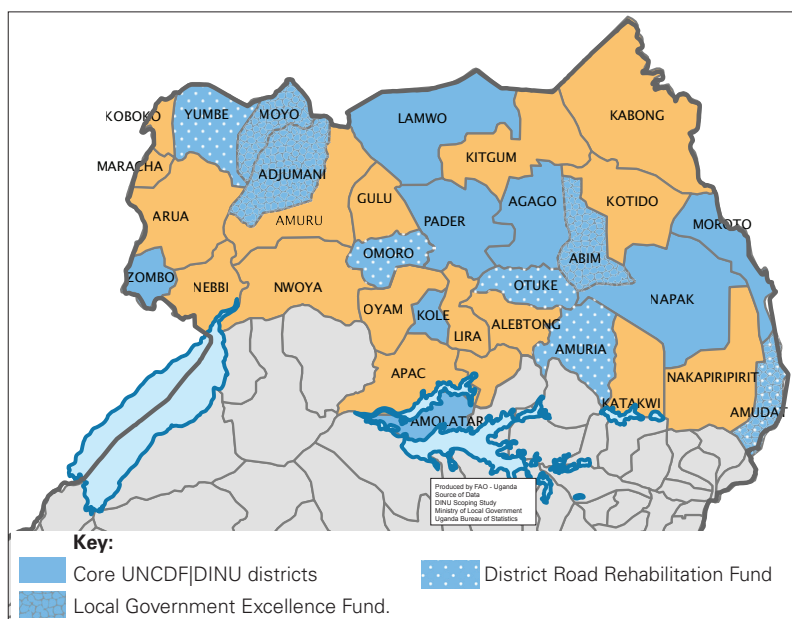

UNCDF project will be implemented in all 38 districts of Northern Uganda, with a special focus on 18 districts, namely: Zombo, Yumbe, Moyo, Adjumani, Lamwo, Omoro, Pader, Agago, Kole, Otuke, Amolatar, Amuria, Abim, Napak, Moroto, Amudat, Kapelebyong and Obongi.



United Nations Capital Development Fund (UNCDF) is the UN's capital investment agency for the world's 48 least developed countries. With its capital mandate and instruments, UNCDF offers "last mile" finance models that unlock public and private resources, especially at the domestic level, to reduce poverty and support local economic development.

By strengthening how finance works for poor people at the household, small enterprise, and local infrastructure levels, UNCDF contributes to SDG 1 on eradicating poverty and SDG 17 on the means of implementation. By identifying those market segments where innovative financing models can have transformational impact in helping to reach the last mile and address exclusion and inequalities of access, UNCDF contributes to a number of different SDGs.

About DINU

The Development Initiative for Northern Uganda (DINU) is a Government of Uganda integrated program financed by the European Union. It is being implemented in 38 districts of Acholi, Karamoja, Lango, Teso and West Nile for a duration of six (6) years (2017-2023).

The overall supervision is with the Office of the Prime Minister through local government in partnership with a wide range of stakeholders.

DINU supports interventions in three specific interlinked sectors: **(1) Food Security, Nutrition and Livelihoods (2) Transport Infrastructures and (3) Good Governance**. Key implementing partners including UNCDF, UNICEF, GIZ and Trademark East Africa have been identified to undertake these interventions according to their specialisations.
